- American Heart Association CPR course (online will NOT be accepted)
- A copy (front and back) of the Blue Card or Letter from the Board of Nursing Texas
- TOEFL (international students only)

Frequent asked questions:

When will I hear back about acceptance?

After deadline allow 2-3 business weeks to hear back from us with an update of acceptance or rejection.

How quickly will I be able to schedule my fingerprints appointment?

The BON makes every attempt to enter rosters within ten (10 business days). They will send an email notification when the information has been entered. Note: Expect possible delays during the peak graduation seasons (May, August and December)

I misplaced my blue card and my school is asking for it. How can I get another one?

The BON mails the original blue card to the address provided by the school on the New and Accepted Student Roster. Other additional courtesy copy can be mailed to an address you specify. Email your request to webmaster@bon.texas.gov Include your full name, date of birth and last four digits of your SSN (if applicable) and inform which address to mail the courtesy copy. Please make sure the subject line of your email: BLUE CARD COPY

When will I hear back from the Board of Nursing about my fingerprints?

Students required to submit fingerprints (first time or a resubmission) will receive an email from Indentogo including a service code and instructions on scheduling their appointment. The Identogo email will be sent to the student's email address provided on the school roster. ASSOCIATE DEGREE NURSING PROGRAM

Accreditation Status: The Midland College Associate Degree Nursing (ADN) program is approved by the Texas Board of Nursing (BON) located at 333 Guadalupe, Suite 3-460, Austin, Texas 78701; phone 512-305-7400.

Program Options: The curriculum of the Midland College Associate Degree Nursing program (ADN) prepares graduates for entry-level nursing practice. Upon completion of the program, approval for licensure by the BON, and successful completion of the licensing exam, NCLEX-RN®, the graduate is licensed as a Registered Nurse (RN). Midland College offers traditional and transition options to obtain the Associate of Applied Science Degree (AAS) in Nursing. The transition option is for a Licensed Vocational Nurse (LVN) who seek career mobility. Both options require the same general education courses to complete the degree. The transition option allows the LVN to receive credit for selected courses through awarded credit. The curriculum degree plans specify the required nursing courses for traditional and transition students. The traditional option requires a minimum of five semesters to complete, including prerequisite requirements. LVNs can complete the transition track in three semesters, after obtaining all of the general education course requirements for the degree. LVN licensure must be kept current during the transition program.

Program Locations: The generic option is taught at the Midland College main campus. The LVN to ADN transition option is taught at the Midland College main campus and transmitted via interactive video to Ft. Stockton's Williams Regional Technical Training Center (WRTTC). Students in the Ft. Stockton area can take these nursing courses, and selected general education courses, at the WRTTC. Clinical instruction is an important component of the nursing program. Hospitals, clinics, and community agencies are utilized each semester in both the Midland/Odessa and Big Spring areas. Students are responsible for their own transportation.

Academic Advisement: The ADN program utilizes selective admission criteria. Admission to the college does not guarantee admission into the nursing program. Initial academic advisement should begin with a college Pathway Advisor to ensure all college requirements are met. Prospective nursing students are encouraged to confer with the nursing department for program-specific advisement. The official degree plan for nursing begins with program admission. Application deadline for the traditional option is May 25 for Fall admission and October 1 for Spring admission. The deadline for the transition LVN to ADN option is October 1 for Spring admission. The number of students admitted each semester depends upon faculty availability and resources.

Admission Requirements - Traditional and Transition Options:

- 1. High school graduate or earned GED.
- 2. Admission to Midland College as a student.
- 3. Submit the online <u>Health Sciences General Application</u>.
- 4. Complete requirements for Midland College's Texas Success Initiative (TSI) unless an exception has been granted.
- 5. Students born and/or educated through a high school outside the United States must pass the internet based TOEFL iBT® (Test of English as a Foreign Language) with a minimum score of 79. The TOEFL score is valid for two years. No Exceptions. Or proof of GED from U.S.
- 6. Achieve a satisfactory score on the nursing entrance examination, the Test of Essential Academic Skills (TEAS). The minimum acceptable score is in the academic preparedness category of "Proficient". If the

- student is not successful on the first attempt there will be six (6) weeks between retakes and only three (3) retakes per admission cycle. The TEAS score is valid for two (2) years.
- 7. Provide official transcripts of all colleges attended to the Midland College Registrar's office.
- 8. Students are selected by a point system and those with the highest points will be selected for admission. The point system utilized is based on the grades which are earned when taking the pre-nursing degree courses and is as follows:

A = 3 pts, B = 2 pts, C = 1 pt. Pre-nursing degree courses taken more than twice will not be eligible for points, no exceptions will be made. The total points must add up to 50 or more for admission consideration; no exceptions will be made.

- 9. Effective for Spring 2021 ADN program, Anatomy and Physiology I & II must have a "B" or better. All other course grades achieved must be a "C" or better. Grades less than a "C" will **not** be considered.
- 10. Student must have an overall college GPA of 2.5 or greater at time of application; GPAs are not and will not be rounded up.
- 11. Provide the nursing department with the following documentation:
 - a. Complete required immunizations record including TB test; must be completed prior to application deadline unless approved by the department chair.
 - b. CPR training must be from the American Heart Association in a Professional Rescuer course (adult, infant and children). Certification must be current at the time of the application deadline and maintained throughout the nursing program. Online CPR is not accepted.
 - c. Only application packets that contain ALL of the information required for consideration of entrance into the ADN program will be accepted (except for the information, which is used for the Texas Board of Nursing clearance).
- 12. BIOL 2401 Anatomy and Physiology I and BIOL 2402 Anatomy and Physiology II must be current within five (5) years of program admission. Speak with the nursing department to discuss options if either or both courses are over 5 years old. Even expired must be "B" or will need to retake course.
- 13. <u>Traditional Option Applicants</u>: Must complete the prerequisite courses listed in the degree plan. All general education courses for the degree may be taken prior to the semester in which they are listed; however, they must be taken no later than the semester that they appear in the degree plan.
- 14. <u>Transition Option Applicants</u>: Must hold a current unencumbered license to practice nursing as an LVN in the State of Texas throughout the program and must complete all of the general education course requirements for the degree prior to starting the program.

Selection for Admission: Admission to the program is competitive. Ranking <u>traditional</u> applicants includes the number of general education courses completed in the ADN curriculum plan and the grade earned in those courses.

Other Program Requirements: Students must comply with all school and nursing program policies. Professional liability insurance is required. It is the student's responsibility to obtain and to keep current health and accident insurance throughout the program. A criminal background check must be started at least two (2) months before the application deadline and be complete prior to program admission. Students are required to pay the fees associated with fingerprint analysis and the criminal background check through the Texas Board of Nursing. A person who has been convicted or received deferred adjudication for anything other than a minor traffic violation, has been diagnosed with mental illness, or has a history of substance abuse, should contact the BON prior to seeking program admission. Eligibility questions can be discussed with the Nursing Program Chair.

<u>Urine drug screening is required each semester</u>. The nursing department schedules the screening date and the student is responsible for the fee.

Assessment Technologies Institute (ATI): The nursing program utilizes ATI teaching, learning and evaluation products throughout the curriculum. Students pay fees each semester to access the materials. Content mastery exams are administered periodically and may be used as part of the course grade. Students take the Comprehensive Predictor exam a few weeks prior to graduation to assess readiness for NCLEX-RN®.

Graduation Requirements: The THECB requires a capstone experience within the curriculum. The program has identified the end-of-program exit exam as the capstone. In addition to completing all course requirements in the degree plan, the candidate for graduation must score satisfactory on the exit exam or prescribed alternative; complete 3-day ATI Live Review for NCLEX-RN course in the same semester as graduation occurs; score satisfactory on the BON's nursing jurisprudence exam; satisfy all college financial obligations; complete a degree application in the registrar's office by the specified deadline; and return any borrowed school property. Participating in graduation and pinning ceremonies is optional, but encouraged.

ATI Test of Essential Academic Skills (TEAS) Information Sheet

What is the ATI TEAS?

The Test of Essential Academic Skills (ATI TEAS) is an internet-based, multiple-choice exam that assesses a student's abilities in four content areas. The test measures basic essential skills in the academic content area domains of reading, mathematics, science, English, and language usage. It is used as one component of the selection process for admitting students to the ADN program at Midland College. The ATI TEAS is a 3 hour and 48 minutes, 170 questions examination with the following format:

- **Reading**: 64 minutes; 53 questions: paragraph comprehension; passage comprehension, inferences/conclusions.
- Math: 54 minutes; 36 questions: whole numbers, metric conversion, fractions and decimals, percentages, ratios and proportions, algebraic equations.
- **Science**: 63 minutes; 53 questions: scientific reasoning, biology, life science, earth science, chemistry, anatomy and physiology, physical principles, general science.
- **English**: 28 minutes; 28 questions: contextual words, sentence structure, grammar and punctuation, word meaning and spelling.

When should I take the ATI TEAS assessment?

It is recommended that you wait to take the ATI TEAS exam until you have completed Anatomy and Physiology I. The test must be taken and passed prior to October 1 for the Spring semester start date.

What score do I need to make on the ATI TEAS in order to apply to the ADN program?

A minimum score of "Proficient" (58.7%) is required to apply to the ADN program.

MULTIPLE ATTEMPTS

The Midland College Nursing department requires six (6) weeks between retakes and only three (3) retakes per admission cycle.

- TEAS testing is available online only at 8:30 am on Thursdays on your own computer
- Reservations must be made before noon on the Tuesday before your preferred test date because a
 systems check will need to be run the day before the exam. For questions, please call the Testing Center

- Further details will be provided when the reservation form has been received.
- Proctoring will be done through ATI Testing and a fee of \$70.00 (includes Proctorio fee) will be charged for each attempt.

- Free test prep resources are available under the TSIA2 (Texas Success Initiative Assessment) tab.
- In-person TSI testing has a \$29.00 testing fee. This is paid at the cashier counter before the exam.
- Online TSI testing has a \$29.00 fee plus \$25.00 fee paid to Examtiy.

IMMUNIZATION SUMMARY

Immunizations required by the State of Texas, Midland College, and/or clinical affiliates

Immunization	
Bacterial Meningitis	All entering students 22 and younger are required to show proof of an initial meningococcal vaccination or booster dose during the five-year period prior to enrolling. The vaccine must have been administered at least ten (10) days before the semester begins.
Measles-Mumps-Rubella (MMR)	Applicant must have one (1) dose of the MMR vaccine or show immunity on Measles, Mumps and Rubella titers.
	Measles - If the applicant was born after January 1, 1957, a second dose of the Measles vaccine (this may be part of a second MMR) is required at least 30 days after the first MMR.
Hepatitis B	A series of three (3) doses is required. The second dose is administered one (1) month after the first dose while the third dose is administered four (4) months from the date of the second dose. A screening titer confirming immunity is acceptable in lieu of vaccine dates.
Tetanus, Diphtheria, Pertussis (TD, Tdap)	The Tdap is preferred since it contains the adult pertussis vaccine. The vaccine must have been administered within the last ten years.
Varicella (Chicken Pox)	Two (2) doses are required at least four (4) weeks apart even if the applicant had the chicken pox previously. A serum titer confirming immunity is acceptable in lieu of vaccine dates.
Tuberculosis Screening	A tuberculosis screen test will be required before acceptance into the program and before classes start. This test must be repeated on an annual basis.
COVID-19	This is no longer a requirement, however if you have received the vaccine, please include the dates you received it/them with your other vaccine records.
Influenza Vaccine (Flu)	An Influenza vaccine test is required after acceptance into the program and before classes start. This test must be repeated on an annual basis.
